D) Programme & Training Committee (07.05.2026, Virtually, 2.30 pm).

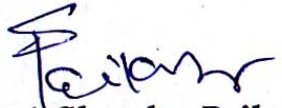
1. An equipment sale counter is to be started at STC, Barunei for smooth availability of material to the near by districts.
